AVAILABLE LIMITS**

- ▶ General liability limits up to \$5 million/\$5 million available
- ▶ Liquor liability limits up to \$3 million/\$3 million available
- ▶ Optional coverages up to \$10,000 limit:
 - Lost deposits (first \$1,000 included for no charge)
 - Damage to wedding attire (first \$1,000 included for no charge)
 - Wedding photography/videography (first \$1,000 included for no charge)
 - Wedding gifts (first \$1,000 included for no charge)
 - Special jewelry (first \$1,500 included for no charge)
- ▶ Optional coverage up to \$50,000 limit:
 - Cancellation or postponement (first \$7,500 included for no charge)

MOST COMMON INELIGIBLE RISK CHARACTERISTICS

- ▶ Weddings that feature firearms or water hazards, or overnight camping
- ▶ Weddings located in AK, CA,* LA or WV
- ▶ Liquor liability for risks located in AL, IA, MS, or RI
